#### Introduction

We are pleased to present our strategic objectives for the period 2016 – 2018.

These objectives are based on the extensive feedback we received from our 17 member groups during a consultation at the end of 2015, and a review of our activities in the preceding three years. They are not a major departure from our previous objectives, but we feel more accurately reflect the current context in which we work, and the needs of our membership network.

In 2016, AVID's 22<sup>nd</sup> year, our role remains unique: we are the only organisation working nationally to promote and support volunteer visiting. Our membership is diverse, with differing priorities and demands, but all share the common aim to reduce the isolation faced by those detained. This remains at the heart of all that we do.

In this document, we have positioned our aims and objectives for the next three years firmly within our belief that detention is unjust. As such we have prioritised working to end the detention of vulnerable people, and we will continue to work collaboratively with our membership to this end. Alongside this we will continue to advocate for improved treatment and conditions for all those in detention, as well as working to raise awareness of the realities of daily life in detention. And as a membership network, we will continue to help build a confident supported and trained body of independent volunteer visitors, ensuring that wherever possible, people in detention have access to the volunteer support that can and does provide a lifeline.

AVID is a support organisation for visitors groups, but we also deliver activities and projects to the benefit of visitors groups and detainees; our work is both proactive and reactive. Our activities in both spheres will take place within this agreed framework.

We look forward to working with our membership to fulfilling these objectives in the coming three years.

AVID aims to address the isolation and injustice of immigration detention in the UK. We do this by supporting, strengthening, and promoting volunteer visiting nationally, and by working towards positive change for all people in detention.

Objective One: To build a skilled, confident, supported and knowledgeable visitors network, by:

Providing support and advice to visitors groups across the UK, with a particular focus on small and developing groups

Increasing visitors access to training and learning opportunities

Promoting best practice in volunteer visiting throughout the network

Providing authoritative information on detention policy and practice

Producing regular information bulletins including our monthly newsletter

Providing an information resource on all aspects of immigration detention
